Pursuant to Article 7, paragraph 1, 5 and 6 of the Law on the Export and Import of Weapons and Military Equipment ("Official Gazette of the Republic of Serbia", number 107/14), Article 136, paragraph 1 of the Law on General Administrative Procedure ("Official Gazette of the Republic of Serbia", number 18/2016), and the Decision of Granting the Power number 002550785 2024 14830 007 007 020 092 of 2 September 2024, deciding on the request placed by Enterprise VINT LLC, Trstenik, Donji Ribnik on 17 June 2024, I hereby make the

DECISION

Explanation
